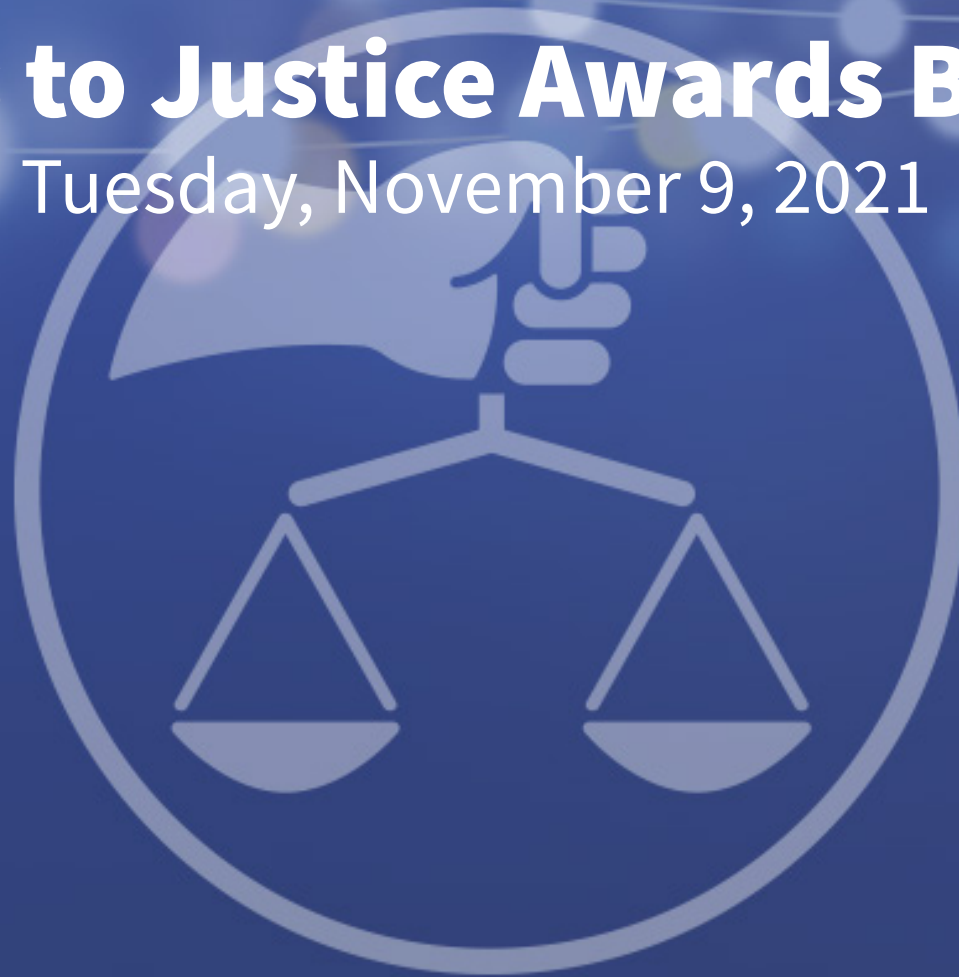

Attorney General Merrick Garland



Attorney General Merrick Garland is tonight's guest speaker.

Attorney General Merrick B. Garland was sworn in as the 86th Attorney General of the United States on March 11, 2021. As the nation's chief law enforcement officer, Attorney General Garland leads the Justice Department's 115,000 employees, who work across the United States and in more than 50 countries worldwide. Under his leadership, the Department of Justice is dedicated to upholding the rule of law, keeping our country safe, and protecting the civil rights of all Americans.

Immediately preceding his confirmation as Attorney General, Attorney General Garland was a judge of the United States Court of Appeals for the District of Columbia Circuit. Before becoming a federal judge, Attorney General Garland spent a substantial part of his professional life at the Department of Justice, serving in both career and non-career positions under five Attorney Generals.

In those roles, his responsibilities spanned the work of the Department, including criminal, civil, and national security matters. They also included direct supervision of investigations and prosecutions of national importance, including the Oklahoma City bombing, Unabomber, and Montana Freeman cases.

Attorney General Garland graduated summa cum laude from Harvard College and magna cum laude from Harvard Law School.

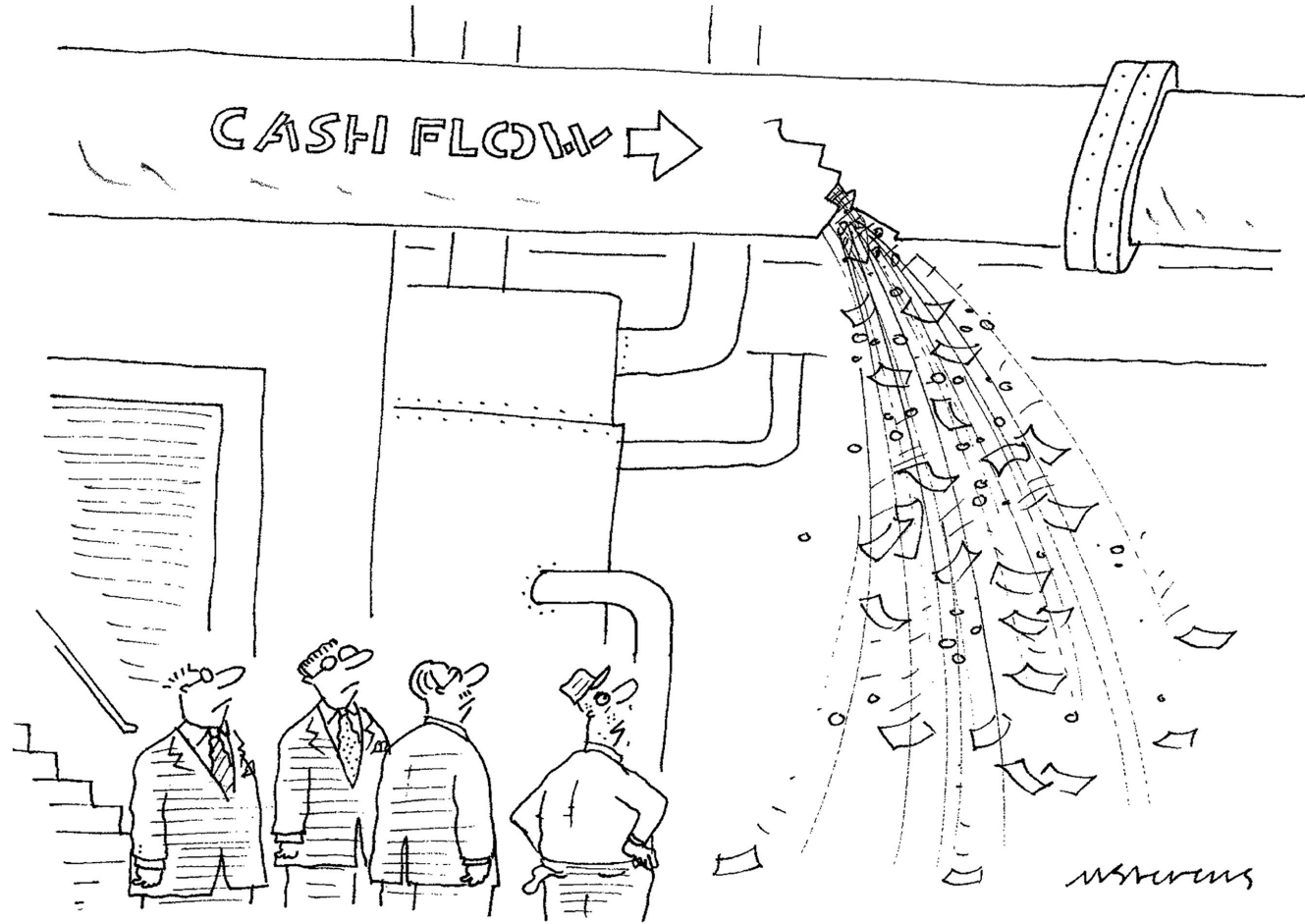

Pro Bono Award of the Philadelphia Bar Foundation



White and Williams LLP has partnered with various civil legal aid organizations in Philadelphia to provide pro bono support for more than three decades. As a supporter of the Philadelphia Bar Association's One Day Pledge, every firm attorney devotes 24 hours annually to pro bono and community service efforts.

Firm attorneys have volunteered with Philadelphia VIP for 35 years serving more than 100 clients with a myriad of different legal issues. In 2007, White and Williams launched their tangled title practice group to work on VIP's more complicated probate and real estate cases. Collectively, the firm's attorneys have made a tremendous impact through their homeownership and tangled title legal work allowing dozens of deserving Philadelphians to stay in their homes. According to an August 2021 study by Pew Charitable Trusts, majority Black neighborhoods in Philadelphia had the highest rate of tangled titles. This disproportionate impact extends further than just the headache caused by a tangled title – tangled titles prevent individuals from building generational wealth through homeownership and making necessary maintenance to their property, which leads to deterioration of the home and the neighborhood.

In partnership with the Homeless Advocacy Project's (HAP) adopt-a-shelter program, the firm provides compassionate legal assistance to residents of Bethesda Project's Our Brothers' Place (OBP). White and Williams' support and dedication through bi-monthly clinics has helped make it HAP's most successful long-term legal clinic site. Firm volunteer attorneys and paralegals have provided legal representation to more than 870 vulnerable residents of OBP, advising them on matters such as veteran benefits, disability benefits, child custody, and housing. During the pandemic, the firm transitioned quickly to staffing virtual, remote HAP legal clinics. White and Williams has been a trusted partner to HAP for more than 25 years.

White and Williams has partnered with Support Center for Child Advocates for more than 35 years, representing children in abuse and neglect matters. The firm's lawyers, paralegals, and support staff have represented more than 100 children in the dependency system. Numerous firm attorneys have served on the Child Advocates board, and three have been recognized with their Distinguished Advocates for Children Award.

White and Williams has been a critical partner to Chubb's Pro Bono Program since 2015, assisting Chubb's staff with running SeniorLAW Center's estate planning clinics. Lawyers and paralegals dedicate many hours to the pro bono program, and the firm provides logistical support, including space for clients and clinics, notarization services, and technology.



Nilam A. Sanghvi, Esq.



Philadelphia Bar Foundation Award

Nilam A. Sanghvi, Esq. is currently the Legal Director of the Pennsylvania Innocence Project, which works to exonerate individuals convicted of crimes they didn't commit and to prevent innocent people from being convicted. The Project has helped secure the exoneration of twenty individuals and has secured the release of three individuals as they continue to fight for exoneration.



With a heavy litigation caseload, Nilam presents training sessions on wrongful conviction and exoneration that she has developed for law firms and in-house legal departments. She also teaches the seminars for the Pennsylvania Innocence Project's exemplary externship program with most law schools in PA, which gives students an opportunity to get hands-on experience with evaluation, investigation, and litigation work and raises awareness among students about the importance of a career in criminal justice reform and fosters a deep commitment to pro bono service. Nilam is an Adjunct Professor at Penn State Dickinson Law and the University of Pennsylvania Carey School of Law. She was also recently elected to serve on the Executive Board of the Innocence Network.

Prior to her work with the Pennsylvania Innocence Project, Nilam was a supervising attorney and teaching fellow in the Georgetown University Law Center Appellate Litigation Program, where she supervised law students representing indigent clients in appeals in federal courts, particularly in immigration cases. Before that, Nilam was a partner in the litigation services department at Schnader Harrison Segal & Lewis LLP. She received the firm's 2010 Earl G. Harrison Pro Bono Award for her leadership and pro bono commitment in the homicide trial of William J. Barnes. Nilam supervised a team that spent hundreds of hours investigating, reviewing, and preparing for the trial, which resulted in an acquittal. While at Schnader, she devoted countless hours to this case and other important pro bono matters.

Nilam has dedicated her life to ensuring equal access to justice and served as a trustee to the Philadelphia Bar Foundation's Board of Directors from 2011-2018. She is a co-founder of the Foundation's award-winning Board Observer Program, allowing cohorts of young lawyers to sit as annual observers on nonprofit boards.



William T. Coleman Jr., Esq.



Trailblazer for Justice Award

William T. Coleman Jr. was born in the Germantown neighborhood of Philadelphia, and spent his career as an attorney in private and public practice fighting to advance civil rights in the United States. He received his undergraduate degree from the University of Pennsylvania and his Juris Doctorate from Harvard Law School, where he became the third black staff member accepted to the Harvard Law Review and the first to graduate first in his class.



Mr. Coleman began his legal career as a law clerk for the U.S. Court of Appeals for the Third Circuit, and went on to serve as the first black Supreme Court clerk. After his clerkships, he hoped to practice law in Philadelphia but was repeatedly rejected because of his race. Instead, he secured a position at Paul Weiss in New York with assistance from his good friend Louis Pollack. In 1952, six years after graduating from Harvard, Mr. Coleman accepted an offer from Richardson Dilworth to practice at Dilworth, Paxson, Kalish & Green where he later became a partner. Mr. Coleman was involved in many major civil rights cases before the United States Supreme Court over his legal career, out of nineteen cases argued before the Supreme Court altogether. He authored the legal briefs presented to the court in *Brown vs. Board of Education*, argued a case that led to the establishment of the constitutionality of interracial marriage and cohabitation, and successfully argued that segregated private schools should be barred from receiving federal tax exemptions.

Mr. Coleman served, in the Johnson administration, as co-chairman of the White House Conference on Civil Rights in 1966. Later, under President Gerald Ford, Mr. Coleman served as the fourth United States Secretary of Transportation and was the second African-American to serve in the United States Cabinet. In addition to decades of private practice, Mr. Coleman was President of the NAACP Legal Defense and Education Fund (LDF) for a year and Chairman for twenty years. In 1987, as co-Chair of the LDF, Mr. Coleman testified before the Senate Judiciary Committee in opposition to the nomination of Judge Robert Bork to the Supreme Court. At the end of his lengthy testimony, then Senator Joseph Biden, as Chair of the Judiciary Committee, remarked:

Mr. Secretary, I must tell you . . . I have been more impressed by you as a witness today than any witness I have ever sat and listened to in any hearing. I knew you were a man of great integrity and passion and feeling, but I am amazed and impressed by the depth of your knowledge of the law, your reverence for the Constitution, and your facility to discuss it. . . .

Mr. Coleman received the Presidential Medal of Freedom from President Bill Clinton in 1995. He passed away at 96 in 2017.



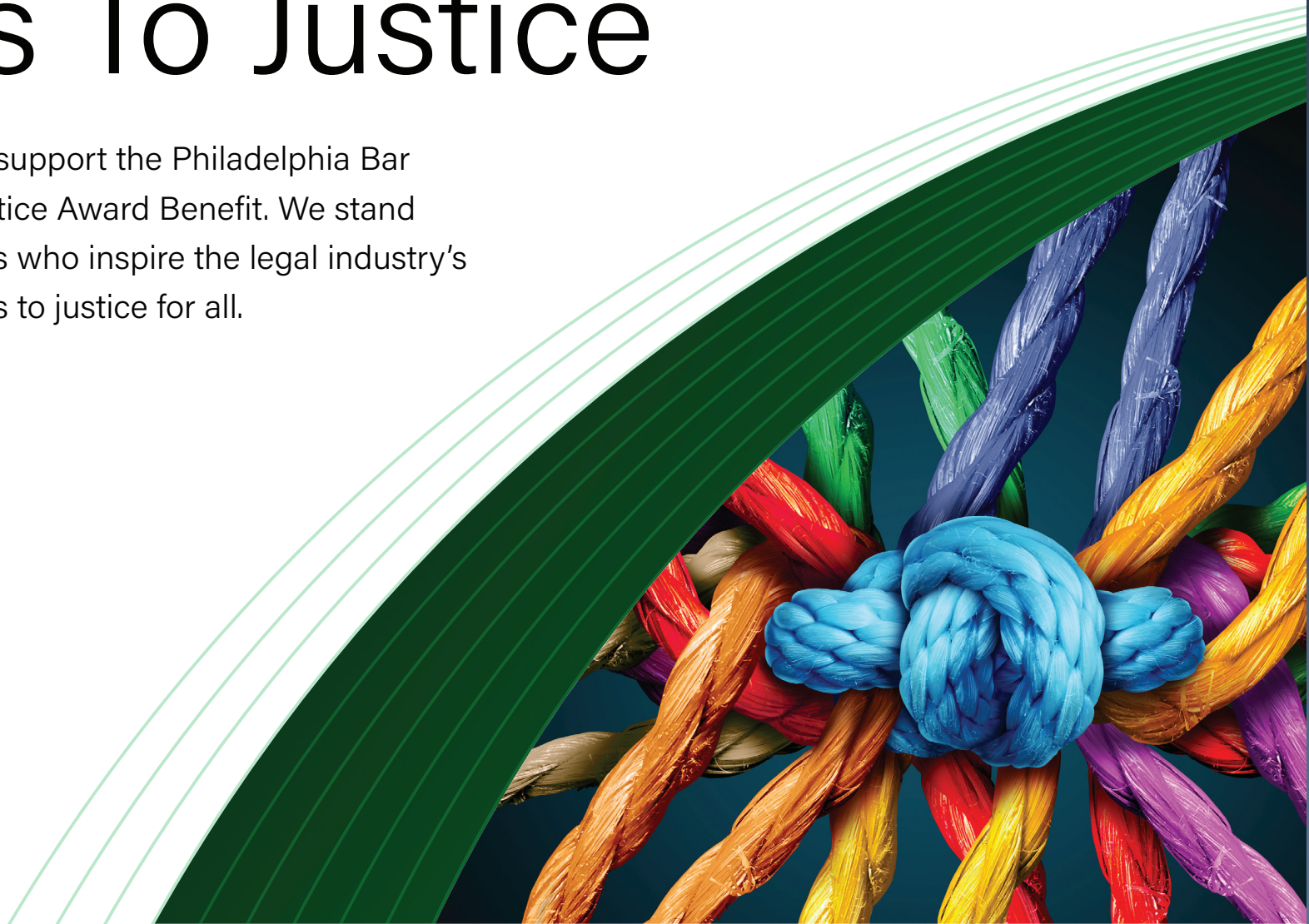

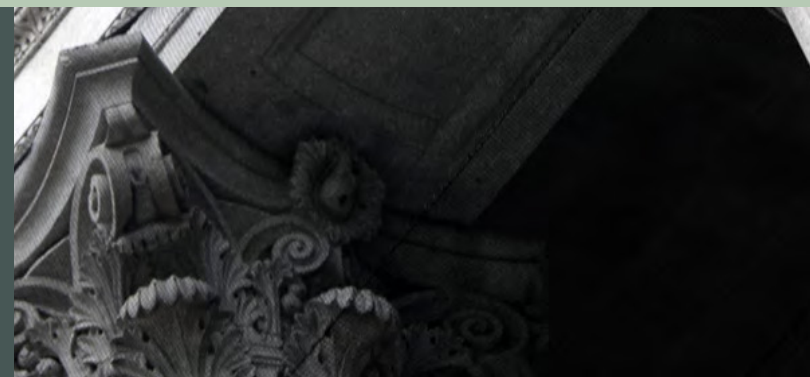
