Letter from the President

Dear Friends,

As we started to move slowly beyond the Covid-19 pandemic, 2022 brought renewed hope to our world. Our Phillies championship season brought us to the World Series. The Eagles powered through to the Superbowl, and the Philadelphia Bar Foundation returned to hosting our Access to Justice Award Ceremony inperson, celebrating our public interest community, civil legal aid organizations, and business partners with actual handshakes and hugs.

In addition to causes for celebration as we began to return to spending time together in-person, 2022 brought many challenges. Courts reversed sacrosanct precedents and fundamental protections that heretofore have protected our access to justice and our democracy were threatened. As we closed out the year, local and national elections and referendums helped renew optimism. Voters championed initiatives to protect individual freedoms and preserve democratic initiatives. We saw a rejection of election denialism and a concerted call for access to justice for all people.

The work of the Philadelphia Bar Foundation has never been more crucial. Through the Foundation's training programs, fellowships, and unrestricted grants to our nonprofit partners, we promote reliability in the law, equal access to justice, and basic human rights and dignity. The Philadelphia Bar Foundation identifies sector-wide needs and marshals the resources to address critical issues in effective and timely ways.



An equitable and well-resourced civil legal system is essential in the fight for a better society. We are grateful that so many supporters in 2022 continued to fund the Philadelphia Bar Foundation's work through Unified Giving from law firms, through corporate and business donations, through individual giving, and donations to the Bar Foundation's various programs.

The need for quality legal services, especially in Philadelphia with its high rate of poverty, constantly outstrips the capacity of the civil legal services system. We must do more, and we can do more to strengthen the capacity of the system and expand access to justice.

I am enormously grateful to our nonprofit partners, who work tirelessly day after day to fight for equal access to justice in healthcare, education, housing, immigration, and more. I am grateful to our donors, Philadelphia's legal and business communities, for your support of our work and our mission. I look forward to seeing you at the Access to Justice Awards Ceremony at the Fitler Club on Thursday, November 9, 2023 to celebrate the work of so many to promote equal access to justice for all.

Support from our generous donors has allowed the Bar Foundation to provide unrestricted grants to our nonprofit partners, in addition to supporting important partnerships that strengthen the public interest and pro bono communities.

Our Mission

Through programs, grants, and partnerships, the Philadelphia Bar Foundation removes barriers to justice, engages the community in support of civil legal aid, and builds system-wide capacity in order to strengthen the provision of quality legal services and to ensure that all individuals understand their rights to equal justice under law.

Ongoing Philanthropic Reflection and Racial Equity

Throughout 2022, the Philadelphia Bar Foundation continued the work to disrupt processes and practices that uphold or perpetuate systemic racism in the civil justice system or white supremacist ideals and systems. The Foundation explored the principles of trust-based philanthropy, participatory grantmaking, and intersectional equity as part of its review of its grantmaking procedures. The Grants Committee of the Foundation adopted a new charter which included undertaking the review and evaluation of the grantmaking process to apply an equity lens, increased transparency to annual, unrestricted grantmaking, and a commitment to consider the impact of the Equal Justice Center Initiatives on the Foundation's grantmaking.

Through the support of a Leadership Grant from the Philadelphia Foundation's Ira Jewell Williams Fund, the Foundation engaged the work of Conducere, a Black-owned, Women-led organizational development firm, to work towards a vision of success which embodies a desire to cultivate an organizational culture where inequalities are addressed, where members of the team actively work to dismantle internal and external barriers to equity, and where diversity is celebrated. As we move forward to the 60th anniversary of the Philadelphia Bar Foundation in 2024 and continue to advance our mission of equal access to justice for all, we need to question, disrupt, and redefine practices in order to build more equitable practices to better serve our community.

Conducere Reports

Through interviews with staff, focus groups with trustees, and workshops, Conducere compiled a list of recommendations for the Foundation's DEI (Diversity, Equity, and Inclusion) initiatives. In conversations among the Board and staff, there was agreement that the primary focus should be on racial equity. Another core focus that was also identified is socioeconomic status (SES). Following-up on these focus areas, Conducere made recommendations regarding fundraising efforts, board membership, staff membership, grantmaking, and community engagement. In 2023, the Philadelphia Bar Foundation intends to continue working with Conducere and to begin engaging with external partners and stakeholders in order to make progress toward achieving these goals.







Programs and Partnerships

The Bar Foundation is Philadelphia's philanthropic hub for access to justice, and the Foundation's work and achievements involve far more than grant-making alone. The Bar Foundation addresses a wide variety of needs in the legal aid sector, providing training programs, fellowships, and assistance for technical and operational issues.

Morris M. Shuster Fellowship

The Morris M. Shuster Fellowship provides forgivable loans each year to deserving public interest attorneys, up to \$5,000 or \$2,500 depending on the attorney's length of service, to help them retire their law school debt. Three legal aid attorneys from three organizations were selected as fellows in 2022.

Samuel T. Gomez Award

To honor the memory of Samuel T. Gomez, Esq., this award was established in partnership with the Asian Pacific American Bar Association of Pennsylvania to annually recognize a law student who demonstrates a commitment to, and passion for, community service.

There was no Gomez Award recipient in 2022 due to circumstances surrounding the ongoing coronavirus pandemic.


International Law Lyon Scholarship Fund

The Philadelphia Bar Association's International Law Committee and the Philadelphia Bar Foundation established the International Law Lyon Internship Fund (the "ILLI Fund") to provide stipends to Philadelphia area law students who participate in the Philadelphia Bar Association – Lyon, France Bar Association exchange program. Participating students intern at a law firm in Lyon for the summer, learning about the legal system in France and completing some pro bono service. There was no Lyon Fund recipient in 2022 due to circumstances surrounding the ongoing coronavirus pandemic.

Judge William M. Marutani Fellowship

In memory of Judge Marutani and in partnership with the Asian Pacific American Bar Association of Pennsylvania, the Marutani Fellowship provides a stipend to subsidize a summer internship position with a nonprofit public interest organization or with a federal, state, or municipal government entity (including the judiciary) in Pennsylvania and the greater Philadelphia area.

R. Nicholas Gimbel Fund for Legal Excellence

The R. Nicholas Gimbel Fund for Legal Excellence supports legal skills training programs, at no cost for public interest lawyers in the Philadelphia area that practice at government agencies and organizations providing access to free or low-cost legal services. In 2022, programing included participation in the American Bar Association's virtual CLE Training on the New Standards for the Provision of Civil Legal Aid and Online Deposition Skills Training.

The ABA Standards for the Provision of Civil Legal Aid have provided guidance to the nation's legal aid organizations on best practices for the delivery of legal services to their clients for sixty years. The Standards underwent a recent revision and redrafting, and the training provided attendees with an opportunity to learn about the standards in-depth, including an ethics-focused portion.

The online deposition training, lead by esteemed professors and attorneys, is intensive online program where participants gather in a virtual classroom to practice NITA's famous deposition training. The training is offered at no cost during an acclaimed three-day intensive program in conjunction with Rutgers Law School. More than 174 lawyers have been trained through the Gimbel Fund program since 2013.

BOARD OBSERVER PROGRAM

The Bar Foundation created the Board Observer Program, in partnership with the Young Lawyer's Division (YLD) and Delivery of Legal Services Committee of the Philadelphia Bar Association, to encourage civic and community engagement and to help strengthen nonprofit boards in our region. The program provides YLD members an opportunity to serve on nonprofit boards including on the boards of the Bar Foundation's nonprofit partner legal aid organizations. The program allows Observers to develop their leadership skills while learning more about their communities and gaining the knowledge and skills necessary for Board service. Participating organizations benefit from the energy and new ideas of these young lawyers. A total of twenty four nonprofit organizations and 29 attorneys participated in this program in 2022.

Judge Alfred L. Luongo Fund

The Judge Alfred L. Luongo Fund supports the "Supervision to Aid Reentry" or STAR Program of the Eastern District of Pennsylvania, helping formally incarcerated individuals succeed in transitioning back to the community. The use of the Luongo Fund has been expanded to also benefit participants in two additional specialized courts in the Eastern District: the Mental Health Protocol program and Relapse Prevention Court, supporting participants facing mental health issues and substance addiction. The Fund was established by Federal District Court Judge Gerald (Jerry) Austin McHugh, Jr. and named in honor of one of his mentors, the late Hon. Alfred L. Luongo.

In 2022, \$3,200 was distributed from the Fund to assist a total of 16 individuals.

Lexis Nexis Research Grants Program

The Lexis Nexis Research Grant Program provides online research time, tools, and training to grantees of the Philadelphia Bar Foundation. A total of ten nonprofit legal aid organizations benefited from this program in 2021.

Diversity Summer Internship Program

The Association of Corporate Counsel Greater Philadelphia (ACC-GP) sponsors an annual full-time, eight-week Diversity Corporate Summer Internship Program, aimed at increasing

diversity within corporate legal departments. Law students who are members of minority groups that are traditionally underrepresented in the legal profession are invited to apply to participate in the program. At a minimum, each intern is compensated a total of \$7,500.00 for participation in the program, though a company may elect to compensate an individual intern at a higher rate. All participants are also required to engage in some form of pro bono service. The Bar Foundation has been a proud partner of this program since 2011. A total of 20 individuals participated in the program in 2021.

2022 Updates

In 2022, our pivot to developing the Equal Justice Center (EJC) Virtual Hub continued. To advance the development of the Virtual Hub, we did a technology scan on emerging technology platforms around the country. In addition, we continued to hold conversations with stakeholders and leadership, to outline a plan to best achieve our goals for the project. This work began with engaging in conversations and learning from leading organizations in the legal aid technology space. With considerations of community and stakeholder engagement, we began seeking strategic partnerships for the advancement of the work.

With the expansion of the effort, leadership determined it was time to seek employees who would be focused on EJC work. With this, the search for the first ever full-time EJC Project Manager and Community Liaison began. These two positions are focused on the EJC Virtual Hub, a navigation portal for civil legal aid in Philadelphia. We look forward to continuing to grow the Equal Justice Center and its work toward universally obtainable civil legal aid information and services.
