R. Nicholas Gimbel was a partner at the law firm of McCarter & English in Philadelphia and a graduate of Yale University and the University of Chicago Law School. His legal experience was as comprehensive as it was varied—clerk for the U.S. Court of Appeals for the Third Circuit, editor of two ABA publications, fellow of the American College of Trial Lawyers, assistant US attorney for the Southern District of New York, adjunct professor at Rutgers Law School, private attorney and litigator.

The R. Nicholas Gimbel Fund for Legal Excellence was created with contributions from friends, colleagues and loved ones to honor Nick Gimbel's memory, his love of the law, and his desire that it be practiced at the highest levels of excellence.

The Gimbel Fund's 2018 Trial Advocacy Training Program, provided through a partnership with Rutgers Law School, will be hosted by Pepper Hamilton and is open to attorneys working at public interest organizations funded by the Philadelphia Bar Foundation (and others as space permits). The three-day course will teach trial advocacy techniques (closing arguments; direct and cross-examination; impeachment; case analysis and preparation). The program will utilize a variety of teaching methods including lecture, demonstration, and courtroom role-playing. There will also be the opportunity to review your performance with experienced faculty.. The Program Faculty will consist of some of the best trial lawyers and teachers from both the region and throughout the country.
