

## 2019 Application for the Evidence Training Program Funded by The R. Nicholas Gimbel Fund for Legal Excellence

R. Nicholas Gimbel was a partner at the law firm of McCarter & English in Philadelphia and a graduate of Yale University and the University of Chicago Law School. His legal experience was as comprehensive as it was varied—clerk for the U.S. Court of Appeals for the Third Circuit, editor of two ABA publications, fellow of the American College of Trial Lawyers, assistant US attorney for the Southern District of New York, adjunct professor at Rutgers Law School, private attorney and litigator.

The R. Nicholas Gimbel Fund for Legal Excellence was created, with contributions from friends, colleagues and loved ones, to honor Nick Gimbel’s memory, his love of the law, and his desire that it be practiced at the highest levels of excellence.

The Gimbel Fund’s 2019 Evidence Training Program, provided through a partnership with Rutgers Law School and Temple University Beasley School of Law, will be hosted by Pepper Hamilton and is open to attorneys working at public interest organizations funded by the Philadelphia Bar Foundation (and other public interest lawyers as space permits). This one day course will teach and highlight the common evidentiary issues confronted by trial lawyers. Topics will include expert witnesses, common evidentiary issues in family law cases, hearsay, impeachment, and others. The program will utilize a variety of teaching methods including lecture, small demonstrations, and interactive problems. The Program Faculty will be led by J.C. Lore and Jules Epstein. J.C. Lore is the Director of Advocacy at Rutgers Law School and Jules Epstein is the Director of Advocacy at Temple University Beasley School of Law.
